Cooled Transported Semen Contract

I hereby agree on _____ day of _____ to breed the mare, _____ registration number _____, to the stallion, _____ registration number _____, using cooled transported semen for the _____ breeding season. Stallion manager _____, Breeding manager _____ (herein referred to as the manager). Stallion owner _____

1. The stallion fee for cooled transported semen is \$_____. This includes the \$_____ non-refundable booking fee which is payable upon execution of the contract. There is a \$_____ charge per shipment for shipping expenses. The remainder of the stallion fee and the first shipping charges are due ten (10) days prior to shipment or the semen will not be sent.
2. A photostatic copy, both sides, of the registration papers on your mare must accompany this contract. The owner recorded on the registration certificate will be the owner recorded on the stallion breeding report.
3. Mares on the premises of Bonnie Becker Reining Horses have a breeding priority on any given breeding day. Therefore, we make no guarantee that cooled semen will be available for transportation on any specific day.
4. Manager collects stallions on an Every-Other-Day Basis. No Exceptions! This is to preserve stallion fertility throughout our breeding season. The manager's breeding season exists March 1st through August 1st.
5. A request for a shipment of cooled transported semen must be made at least 24 hours prior to shipping time. Cancellation must be made by 8:30 am (Mountain Standard Time) shipping day. Failure to cancel by 8:30 am will result in a \$_____ shipping charge. Cancellations can be made by telephone or fax. Semen will only be sent via counter-to-counter air transport services (Air Canada, West Jet, Integra Air), Greyhound Bus, Express Post, or Courier.
6. Upon shipment of the cooled transported semen to the mare owner the semen shipment container received must be returned to Bonnie Becker Reining Horses within 5 days of receiving the semen shipment. If the semen shipment container is not received at Bonnie Becker Reining Horses within 10 working days the mare owner will be charged for the replacement of the semen shipment container. If disposable shipment container has been used, disregard #6.
7. This contract contains a "Live Foal Guarantee". A live foal is described as a newborn foal which stands and nurses without assistance. If a foal is born dead, or the mare absorbs/aborts a predetermined pregnancy there are return privileges, only if the manager is notified within thirty (30) days and receives a statement confirming this. A "Live Foal Guarantee" will apply only to those mares that are certified in foal by a licensed, attending veterinarian. Confirmation of such pregnancy in the form of documented ultrasound picture or letter from the attending veterinarian must be received by October 1 of the breeding year or the mare will not be included in the Stallion Breeding Report.
8. If the mare absorbs or aborts a pregnancy after having been checked in foal, or if the mare fails to conceive during normal breeding season, the manager agrees to breed the same mare again during the immediately following year's breeding season. There is a charge of \$_____ for re-breed service expenses plus a shipping fee of \$_____. A substitute mare, accepted by the manager, may be used ONLY if the original mare is deceased or deemed unfit for breeding by an accredited veterinarian.
9. A Breeder's Certificate will be issued for the foal conceived as a result of the breeding. The Breeder's Certificate will be issued only after all the expenses have been paid in full and after the foal is born and has been reported to the manager.
10. Neither Bonnie Becker Reining Horses nor any of its officers, employees or managers shall be liable for damages as a result of damage to the semen or as a result of a mare failing to settle. Bonnie Becker Reining Horses' sole liability under this contract is in the event the stallion should die or become unfit for the breeding purposes this contract shall terminate and any money paid on the stallion fee, except the non-refundable booking fee, shall be refunded to the Mare Owner.
11. When signed by both parties this document will become a legally enforceable contract, binding upon both parties. The parties acknowledge that this agreement is made and shall be considered to be entirely performed and shall be construed and enforced under the laws of the province of Alberta. An equine professional is not liable for an injury or death of a participant in equine activities resulting from the inherent risks of equine activities.
